## DIRECTIONS FOR USE

Situation	Application Equipment	Rate	Critical comments
Broadacre - Diagnostic soil test	Band spray for furrow seeding behind press wheels at 9-12 inches (20-30 cm spacing)	As recommended from diagnostic soil test Refer to Application section for specific rates	Spray pressure should be high enough to maintain a reasonably strong jet. Apply with water rates of 30-50 L/ha. Avoid direct contact between seed. For best results, apply to dry soil. Avoid shallow seeding depth.
Broadcast spray application	Boom sprayer	20 L/ha	Spray pressure should be high enough to maintain a reasonably strong jet. Apply with minimum water rates of 100 L/ha. Avoid direct contact between seed. For best results, apply to dry soil. Avoid shallow seeding depth.
Turf management, lawns, fairways and playing fields	Boom sprayer	20 L/ha	Apply every 30 days in at least 400 L of water per hectare. Water after application to remove product from foliage. Supplemental treatment of tees and greens will be required due to the diluted rate of application common with irrigation injections systems.

## GENERAL INSTRUCTIONS

DIVINE® AGRI can be used at sowing to improve soil water penetration and water holding capabilities of non-wetting soils. DIVINE® AGRI can be applied with DIVINE® INTEGRATE to provide optimal site-specific results. Undertake a diagnostic soil test to determine the correct mixing ratio of DIVINE® AGRI and DIVINE® INTEGRATE. Refer to the DIVINE® INTEGRATE label for further information.

## APPLICATION

For best results, apply to dry soil. Avoid shallow seeding depth.

Apply by band spray technique through nozzles mounted behind the furrow forming press wheels. Nozzles should be sited as close to the ground as possible. The spray stream should be directed so that DIVINE® AGRI is applied to settled soil and not mixed with soil. Suitable nozzles are cone nozzles without the swirl plates which produce a jet stream. The use of plastic or ceramic nozzles is preferred as DIVINE® AGRI may cause steel nozzles to oxidise.

## Diagnostic soil test

The appropriate rate of DIVINE® AGRI is dependent on the results from diagnostic soil tests. Refer to the table below to determine the ratio in which the DIVINE® AGRI and DIVINE® INTEGRATE has to be mixed to achieve the site-specific recommendation required.

## WITHHOLDING PERIOD

No special withholding period is required when DIVINE® AGRI is applied according to the label.

## STORAGE AND DISPOSAL

Store in the closed, original container in a dry, cool, well ventilated area out of direct sunlight. Triple rinse containers before disposal. Add rinsings to spray tank. Do NOT dispose of undiluted chemicals on site. If recycling, replace cap and return clean containers to recycler or designated collection point. If not recycling break, crush, or puncture and deliver empty packaging to an approved waste management facility. If an approved waste management facility is not available, bury the empty packaging 500 mm below the surface in a disposal pit specifically marked and set up for this purpose, clear of waterways, desirable vegetation and tree roots, in compliance with relevant local, state or territory government regulations. DO NOT burn empty containers or product.
